Are there services covered before you meet your deductible ?	Yes. Primary Care, Specialty Care, some Prescription Drugs, Urgent Care, and Pediatric Dental and Vision are covered before the deductible.	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply.
