<p><b>What is the overall <a href="#">deductible</a>?</b></p>	<p>\$0 – Individual or                      \$0 – Family</p>	<p>See the Common Medical Events chart below for your costs for services this <a href="#">plan</a> covers. Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a>, each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a>.</p>
<p><b>Are there services covered before you meet your <a href="#">deductible</a>?</b></p>	<p>Yes. <b>Will you pay less if you use a <a href="#">network provider</a>?</b>	Yes. ### Does this plan provide Minimum Essential Coverage? Yes
