<p><b>Are there services covered before you meet your <a href="#">deductible</a>?</b></p>	<p>Yes. <b>What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a>?</b>	\$8,700 – Individual or \$17,400 – Family	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services. ### Does this plan provide Minimum Essential Coverage? Yes

[Minimum Essential Coverage](#) generally includes plans, health insurance available through the Marketplace or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of [Minimum Essential Coverage](#), you may not be eligible for the premium tax credit.

### Does this plan meet the Minimum Value Standards? Yes
